Strong emphasis will be placed on experience and track record in high quality research. The scholar will be expected to mentor early career researchers towards engaged and high impact scholarly research of a quality that can be published in leading journals in their field. To this end the person will support and deliver seminar series, roundtable discussions, and working groups at the college. The scholarship will strengthen the relationship between the college institutions through shared research and co-authoring opportunities. Fulbright Scholars will be asked to give public talks and otherwise engage in the host community to support the aim of expanding and strengthening international relations.
